“EAGLE IS HOME” POSTCARD**

OVERVIEW:

Calling all photographers! The Eagle Arts Commission (EAC) is pleased to provide photographers the opportunity to submit photographs for an exclusive Eagle postcard project followed by a photographic exhibition to be held at City Hall in July 2019. The theme is “Eagle Is Home.” Submissions must depict images of structures, locations or events unique to Eagle. Four (4) creative individuals will be selected. The four (4) photographs that are chosen, will be used to create an “Eagle Is Home” 4”x6” postcard. The postcards will then be sold. The selected photographers will each be awarded \$ 200.00 for their winning submission.

ELIGIBILITY:

1. Professional and amateur photographers are encouraged to apply.
2. All photographs must be original. No reproductions, posters, or giclée prints will be accepted.
3. All submissions MUST include a cover letter explaining the submitted work.

SUBMITTAL REQUIREMENTS:

1. Photographer to provide up to four (4) digital images of “Eagle is Home” photography on a non-returnable thumb drive or cd. Digital images shall be in JPG format and not exceed five (5) megabytes in size. File label format shall be: Artist Last, First Name_Title
2. Cover letter and resume (optional) addressing education and past shows.
3. All submissions shall be in color.
4. Signed Property Rights Release form (will only be used if chosen).
5. Waiver for Minors

SELECTION CRITERIA:

1. Adherence to the call for Photographer requirements; (5 points)
2. Cover Letter (resume optional) (5 points)
3. Photographs must demonstrate an understanding of the “Eagle Is Home” theme. (5 points)
4. Submissions are of discernable Eagle locations or events (please include general location of photograph). (5 points)

EXHIBIT INFORMATION:

1. All accepted photographers who submitted photographs for the “Eagle Is Home” Call for Photographers are allowed to display one (1) photograph in the July 2019 exhibit.
2. Photographers will be represented by one (1) framed 8” x10” submission.
3. Four creative photographers will be chosen for the Eagle is Home postcard. First, Second and Third place ribbons will also be awarded in addition to two honorable mentions.
4. A reception will be held at Eagle City Hall on July 5, 2019 at 6:00 pm.

APPLICATION DEADLINE:

Deadline for submittals is Friday, February 22, 2019 at 5:00 p.m., Mountain Standard Time (MST).

Mail or hand deliver submittals to: City of Eagle, Attn: City Clerk’s Office, 660 East Civic Lane, Eagle, Idaho, 83616. Due to size constraints, email submittals will be not accepted.

Any photograph reproduced will include a photographer credit as feasible. The City of Eagle will not be required to pay any additional consideration or seek any additional approval in connection with such uses.
